- **Buffalo Creek Forest Preserve:** Expanded 70 acres of wetlands, added over a mile of multiuse trail, and installed a water control structure.
- **Sugar Creek Golf Course Restoration:** The project involves stream stabilization, construction, wetland creation, sediment & debris removal, grading, seeding, planting, & site restoration. Topsoil/unsuitable materials removed. All disturbed areas must be restored.
- **Hammel Woods Dam:** Removed a low-head dam, stabilized banks, enhanced with rock, built a canoe/kayak launch, & installed native seed.
- **Lake Opeka Shoreline Restoration:** Features a 40-acre lake, stabilized with approximately 5,500 linear feet of shoreline, & includes a 3-year landscape management plan, 7 fishing piers, 12 aquatic shelves, & 0.75 miles of asphalt trail
- **Forked Creek Envirolock Soil Bags:** Stabilized over 600/300 square feet of streambank using various techniques, including stone toe & gabion baskets, along with native plant installation.
